# Review Approach

## Step 1 – Approach

In order to maximize the amount of covered content in the “Planning Discussions” and “Implementation Strategy Matrix”, we will again pair them by Values into three stations (i.e. tables) as follows:

- **A Welcoming Place & A Livable Community**
- **A Connected City & A Healthy Lifestyle**
- **A Competing Economy & A Sustaining Environment**

# Review Approach

## Step 2 – Process

- **The small group review process will utilize two 30-minute rounds of conversation with 3-4 committee members and 1 staff facilitator seated around a table at each station. At the end of the 30 minutes, each member of the group moves to a different new station (i.e. table). Only the staff facilitator stays at the station to welcome the next group and briefly fills them in on what happened or what was shared in the previous round.**
- **After the two 30-minute rounds of conversation, we will have three 10-minute rounds of report out where the table facilitator will share with the entire committee the various comments or feedback that was provided during the small group conversations. During this time, members of the committee will have a final chance to offer any closing observations based on the discussion summary.**

# Review Guidance

- **The current General Plan 2035 is provided for reference as needed.**
- **Utilize the packet to see where existing Goals or Policies are addressed in the Draft Goals & Policies for General Plan 2040 for all the Values.**
- **RESIST THE URGE TO WORDSMITH, focus on broad thoughts and direction.**

# Guiding Review Questions

- **Is the wording of the Goal and the Goal Description consistent?**
- **Do the Policies help to support or achieve the Goal?**
- **What is missing? Are there any terms, issues, trends that are missing or not sufficiently addressed? (keep in mind they may be covered in other Values)**
- **Do all the Goals and Policies seem to be in alignment with their associated Value?**
